To commemorate the 48th anniversary of the announcement of the Green March by His Late Majesty King Hassan II, the Royal Institute for Strategic Studies (IRES) has released the White Paper on the Moroccan Sahara in Arabic, French, English, and Spanish on its website.

Morocco's reputation in the world in 2023

IRES, in collaboration with "Reputation Lab," an international firm specializing in "Nation Branding," has published its report on Morocco's global reputation in 2023. The report, which garnered significant national and international attention, ranked Morocco 34th out of 60 countries with the highest GDP in terms of reputation among G7 countries and Russia. Morocco's overall positive international image remained intact in 2023, comparable to that of Peru and surpassing countries like the United States and Argentina, except for Brazil, which slightly outperformed Morocco by 0.2 points, as well as the reputation of all African countries and those of the Arab world.

Relations between Morocco and Nigeria

IRES has conducted a study analyzing the political and economic situation in Nigeria, with a focus on exploring cooperation and investment opportunities between Morocco and Nigeria in various fields, both bilaterally and within continental bodies.
